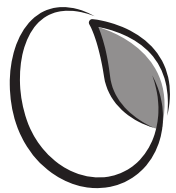

- ☒ Between the ages of 19 and 32 years old.
- ☒ Tobacco-free and no history of drug or alcohol abuse.
- ☒ Physically healthy, with regular monthly menstrual cycles and a healthy BMI.
- ☒ No family history of bipolar, schizophrenia, or other inheritable genetic diseases.
- ☒ Willing to undergo a medical and psychological evaluation.
- ☒ Willing to self-administer injectable fertility medications.
- ☒ Dependable and committed to the egg donation process.



# Anonymous vs Known Egg Donations

## ANONYMOUS CYCLE DONATION

In an anonymous donation, the recipients and egg donor's identities will remain confidential and no identifying information will be exchanged. You will never meet or know each other's names. Only relevant information will be provided about the donor, including medical and genetic history, description of their physical characteristics, photographs of the donor, and photographs of their children (if applicable).

The information shared with your donor will be the clinic location, your marital status (single or partnered), and if you will be requiring a surrogate to carry the pregnancy.

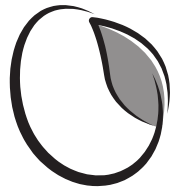
After speaking with a social worker or psychologist at the fertility clinic, most intended parents and egg donors are most comfortable and choose to move forward with an anonymous donation.

## KNOWN CYCLE DONATION

In a known donation, all parties have agreed to disclose information about each other such as last names, locations, occupations, etc. The recipient parents and the egg donor may choose to meet either virtually or in-person before the egg retrieval takes place. Everyone is mutually interested in maintaining contact, potentially throughout the life of the children born as a result of the donation.

In a known donation, it is important that all parties have discussed their long-term expectations of the relationship and what the donor's future relationship will be with the children.

There are many issues to consider when choosing a known donation, but it can be a wonderfully positive experience for the recipient parents, the egg donor, and any future children that may result.

# Frequently Asked Questions

## Q: How are egg donors selected?

Egg Helpers eliminates women who have medical and social histories that make them unacceptable. We seek healthy women whose families do not have genetic problems that could be passed on to a child.

## Q: What motivates someone to donate their eggs?

Our egg donors have expressed that they donate because they are motivated by a desire to help someone in their quest for parenthood.

## Q: How do I find an egg donor that has my traits?

Because ethnicity, body type and lifestyle play an important part in the donor selection process, Egg Helpers can find egg donors from various backgrounds who are willing to help future parents.

## Q: What type of information do future parents receive?

Donors are required to provide personal and family history by completing our questionnaire. This information, along with photographs of the donor, is provided to the future parents in making a donor selection.

## Q: What does the egg donation process consist of?

Egg donors receive complete information about the egg retrieval process and any risks or complication that could occur. Each selected egg donor meets with a psychologist who provides a written report about her mental suitability for being a egg donor.

## Q: How does a donor know what her responsibilities are?

## Q: How does an egg donor receive reimbursements?
